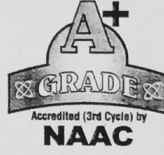



This is in continuation of my letter Ref.No.BVDU/A8/2017-18/1080 dated 1<sup>st</sup> July 2017 with regard to the constitution of Internal Complaints Committee (ICC), in pursuance of the UGC's (Prevention, Prohibition and redressal of sexual harassment of women employees and students in Higher Educational institutions) Regulations, 2015, in all constituent units of Bharati Vidyapeeth Deemed University, Pune.

In view of a complaint received from a lady against one of the staff members of the university, it is felt that the presence of a lady legal advisor in the Internal Complaint Committee shall be helpful in the process of investigation. In this regard, on behalf of the Board of Management of the University, I hereby nominate Dr.Ujjwala Bendale, in place of Prof.Dr.Mukund Sarada, as a Co-opted Legal Advisor in the Committee. The constitution, duration and functions of the committee shall be the same, as per my previous letter dated 1<sup>st</sup> July 2017, in compliance with the UGC guidelines.
